# Customer Representative/s Authority Form

## ATTACHMENT A – PROOF OF IDENTITY

This form must attach proof of the Customer's identity by providing a legible, colour copy of at least one of the following forms of identification. The Customer must sign and date each document provided as proof of identity with this form.

a) **For Customers who are individuals:**

- i) Australian or international driver's licence (current, or expired within the previous two years, but not cancelled);
- ii) Australian or international passport (current, or expired within the previous two years, but not cancelled);
- iii) birth certificate/birth extract; or
- iv) Australian Citizenship Certificate.

b) **For Customers who are companies:**

- i) certificate of registration of a company issued by the Australian Securities and Investments Commission displaying the Australian Company Number (ACN) or certificate of registration of a Registrable Australian Body displaying the Australian Registered Body Number (ARBN) where the company is an overseas entity;
- ii) registration from the relevant authority in its country of origin;
- iii) verification of company via the Australian Securities and Investment Commission [www.asic.gov.au](http://www.asic.gov.au) (ie an extract); or
- iv) official company document displaying the ACN or ARBN of the company (such as a company cheque).
